## **1 GENERAL OBJECTIVE AND CONTENT**

The Sanlorenzo Group, being aware that respect for the environment is an essential requirement of correct business management, undertakes to:

- Maintain compliance with all applicable environmental laws and regulations;
- Pursue continuous improvement aimed at increasing environmental performance and reducing environmental impacts;
- Pursue pollution prevention, climate change mitigation and adaptation, effective use of natural resources, optimal management of waste and water resources, and protection of biodiversity.

## **2 ADOPTION AND IMPLEMENTATION**

The Environmental Policy is approved by the Board of Directors of the Parent Company Sanlorenzo S.p.A.

Responsibility for its implementation lies with the relevant departments within the various Group companies, where present, or alternatively with the employer, which are called upon to ensure its effective application, promoting the dissemination of the policy objectives and fostering an environmentally aware culture.

### 3 SCOPE OF APPLICATION AND REFERENCES

This Environmental Policy has been developed in compliance with the principles and requirements of UNI EN ISO 14001:2015 and applies to all the companies of the Sanlorenzo Group. Application is also extended to non-certified companies, which are required to comply with the principles and commitments expressed in this Policy, promoting the progressive integration of environmental management systems. The complete list of certified companies is available in the Annex section, to which reference should be made for further details.

### 4 PRINCIPLES OF THE POLICY

The Sanlorenzo Group, aware of its responsibility towards the environment and the context in which it operates, undertakes to:

- Manage activities with the aim of minimising environmental impact relative to energy consumption, including through the implementation of environmentally friendly production technologies;
- Monitor and reduce greenhouse gas (GHG) emissions in all business activities, in line with EU decarbonisation targets and Paris Agreement commitments;
- Use natural resources effectively, minimising the environmental impacts related to raw materials used in the production of vessels, including through promotion of production solutions aimed at recovery and reuse of raw materials, and through research and introduction of alternative materials with lower impact;
- Safely manage chemical and hazardous substances, reducing their use and promoting their replacement with less impactful alternatives, where possible;
- Integrate environmental criteria in the planning and management of activities, both under normal conditions and in emergency situations, assessing physical and transitional risks related to climate change;

- Promote the selection of suppliers that align with the principles expressed in this policy;
- Evaluate and monitor the activities of contractors for the purposes of proper coordination of the different phases of the work processes, and of adequate awareness and training regarding the environmental impacts that result;
- Promote the responsibility of employees at all levels towards environmental protection, implementing internal workforce information and training programmes;
- Ensure cooperation with public authorities and supervisory bodies;
- Minimise and optimally manage the waste produced by the production cycle, promoting waste separation and recovery;
- Promote the design of new models that comply with high standards of environmental sustainability, through the integration of ecodesign criteria and the adoption of construction solutions with reduced environmental impact;
- Protect biodiversity through compliance with current legislation on protected areas, thereby preventing and minimising impacts on ecosystems and natural environments;
- Promote responsible and efficient management of water resources in all areas of Group operation, with particular attention to those subject to water stress, adopting initiatives and measures aimed at reduced consumption;
- Offer customers products designed and manufactured according to safety, quality and environmental sustainability criteria, using innovative technologies and low-impact materials, and guaranteeing high performance while respecting the environment.

## 5 METHODS OF DISSEMINATION

This Environmental Policy is made available to all Group personnel through internal communication channels, in particular through Sanlorenzo S.p.A.'s corporate intranet.

It is also published on the corporate website of Sanlorenzo S.p.A., so that it is accessible to all external stakeholders, including customers, suppliers, business partners, local communities and competent authorities.
